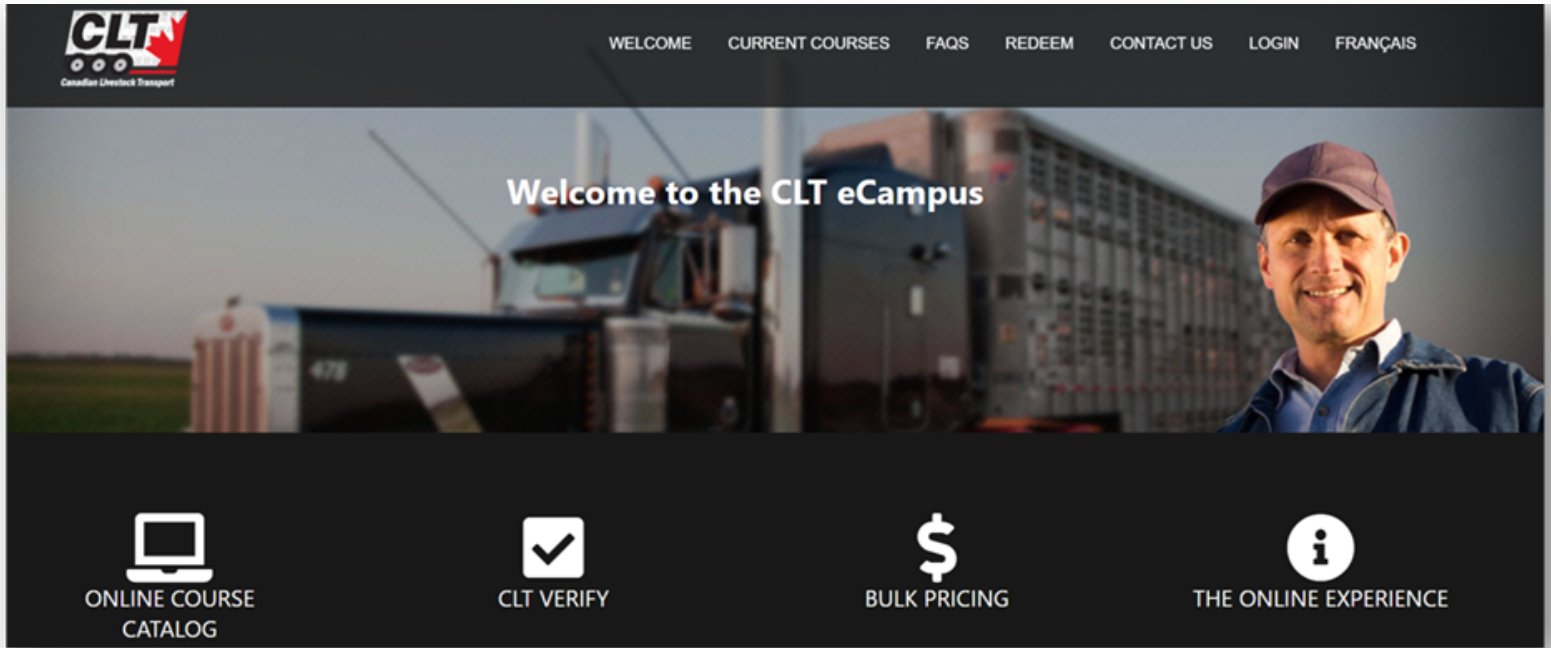

## UPDATED TRAINING AVAILABLE

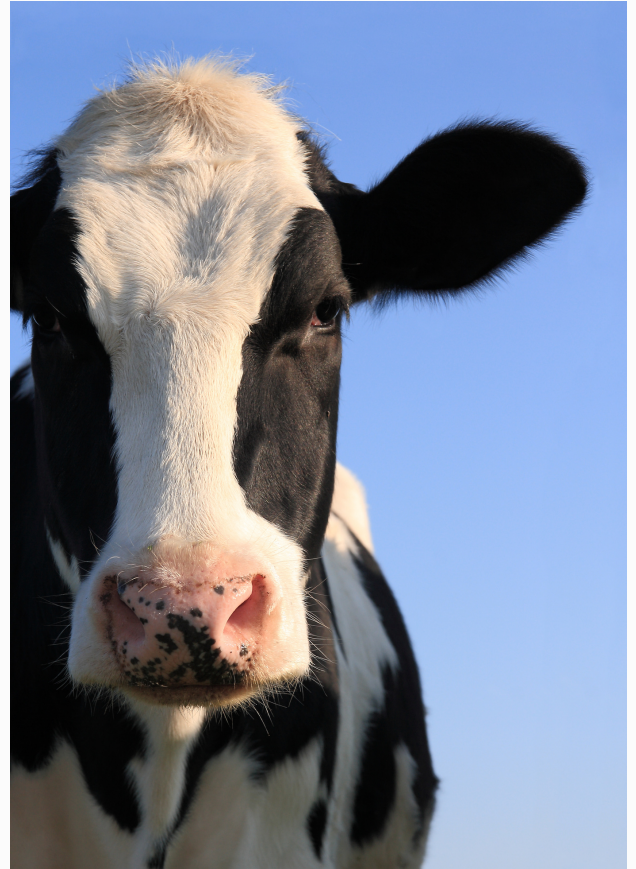
The CLT training program was brought under the guidance of the National Farmed Animal Health and Welfare Council (now [Animal Health Canada](#)) in July 2020. Both courses [Transport of Livestock](#) and [Transport of Poultry](#), available online in English and French and also with Spanish exams, have been updated to align with the current best practices and evolving legislative requirements. As you may know, the amendments to Part XII of the [Health of Animal Regulations](#), the Transport of Animals, were published in February 2019 and came into force in February 2020.

## DAIRY CALVES AND CULLED CATTLE

A complimentary online course and support resource developed for those with roles and responsibilities in the transportation of dairy calves and cull cattle is [available on-line](#) and is free of charge. The course explains the transportation regulations in three parts: cattle behaviour and handling, transportation steps and preparation, and risk management. This training was created by Les Producteurs de bovins du Québec, Gestbeau in partnership with Dairy Farmers of Ontario, Veal Farmers of Ontario, Beef farmers of Ontario, Dairy Farmers of Nova Scotia, Dairy Farmers of Prince Edward Island, and Agri-Commodity Management Association (including Prince Edward Island Cattle Producers, New Brunswick Cattle Producers, Nova Scotia Cattle Producers).

## DID YOU KNOW?

**Transport Code:** The livestock and poultry transport sector may not have a national organization, but many of you are involved in a collaborative effort to review the 2001 recommended Code of Practice for the care and handling of farm animals: Transportation. A lot has changed since 2001. The work is being done under the guidance of the National Farm Animal Care Council (NFACC). **Health of Animals Regulations:** As of February 20, 2022, the Canadian Food Inspection Agency (CFIA) temporary 2-year compliance promotion period, provided for the prescribed FWR interval provisions, ended. In their release, the CFIA is indicating that it will continue to use its discretionary power to enforce all humane transport requirements and to prevent and act on animal welfare situations.
